A regular meeting of the Board of Trustees of the Village of Elwood, Nebraska was held at the Elwood Village Office, 304 Calvert Avenue on Monday, April 18, 2022. The meeting was called to order at 7:00 pm by Board Chair Martin who acknowledged the Open Meetings Act posted on the south wall of the meeting room. Present were Trustees Townsend, Kleine and Tilson. Trustee Fong was absent. Notice of the meeting was given in advance thereof by publication in the Valley Voice Newspaper on April 7, 2022 and by posted notices at Security First Bank, Pinnacle Bank, Elwood Post Office and the Village Office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

A motion was made by Tilson, seconded by Kleine, to approve the March 15, 2022 regular meeting minutes. There being no discussion, the roll call vote was: ayes: Townsend, Kleine, Tilson, Martin; nays: none; absent: Fong; motion carried 4-0-1.

A motion was made by Kleine, seconded by Tilson, to approve and pay the Village and Library claims correcting the claim by Municipal Supply from 225.14 to 112.57. The roll call vote was: ayes: Townsend, Tilson, Kleine, Martin; nays: none; absent: Fong; motion carried 4-0-1. Claims are as follows:

A motion was made by Tilson, seconded by Townsend to approve the financial reports. Roll call vote was: ayes: Kleine, Townsend, Tilson, Martin; nay: none; absent: Fong; motion carried 4-0-1.

The Trustees reviewed the minutes from the Community Redevelopment Authority (CRA). CRA Board Chair Katy Weissert was present to report that two lots have been approved for the building of houses. There was one business loan request that will not qualify for lot improvement according to the Nebraska Community Development Law.

Nicole Atterberry was present to ask the Board for an adjustment on the number of chickens allowed on a chicken permit. The Trustees will review the ordinance.

Sheriff Ward informed the Trustees that the new contract with the Sheriff's office will be ready soon. There was a brief discussion about vehicle parking and unlicensed vehicles.

Utilities Superintendent Corder reported that lights at the ball fields will be put up soon. The cemetery has been full of corn shucks in areas due to the high winds and they have been cleaning out there. Corder had an estimate on sprinklers (about \$20,000) and surface material for the baseball field and additional surface material on the softball field (about \$9,000) and for treating the grass (in claims, \$3589.00). A motion was made by Tilson, seconded by Townsend to install sprinklers in the baseball field, get the surface material for both fields as needed and do the grass treatments using sales tax funds. There being no further discussion, the roll call vote was: ayes: Kleine, Townsend, Tilson, Martin; nays: none; absent: Fong; motion carried 4-0-1.

Discussion was held regarding water at the cemetery and possible turning on water before Memorial Day and leaving on for several weeks. Trustee Tilson also discussed the possibility of electronic directory at the cemetery.

Pool applications were reviewed and a motion was made by Tilson, seconded by Kleine to hire Madison Clouse as the pool manager and one additional lifeguard. There being no discussion, the roll call vote was: ayes: Townsend, Kleine, Tilson, Martin; nays: none; absent: Fong; motion carried 4-0-1.

The Board was informed that the Village of Eustis agreed to pay for half of the ball league fees for the teams and also pay for the coaches.

Trustee Tilson discussed the village office flooring and lighting with the Board as all is still original paint, flooring and lighting. It was agreed to obtain bids for these items.

A sidewalk improvement program was discussed which would allow the Village to assist residents with improving their sidewalks.

Trustee Tilson discussed getting solar panels and having someone come to discuss with the Board.

The Trustees briefly discussed changing the regular meeting dates. No action taken. Board Chair Martin adjourned the meeting at 8:51 pm.
